ORDINANCE NO. 495

**AN ORDINANCE APPROVING THE FINAL PLAT OF
SPRINGCREST SUBDIVISION**

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have heretofore approved the Final Plan and Final Plat of Springcrest Subdivision, which plan and plat meet all requirements of the Subdivision Code of the City of LeRoy; and

WHEREAS, there has been submitted to the City of LeRoy a final plat of SPRINGCREST SUBDIVISION (Exhibit I, attached hereto and incorporated herein by reference) which in all respects substantially conforms to the plan approved by the Mayor and City Council, and all other requirements of the Subdivision Code of the City of LeRoy having been met,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. The final plat of SPRINGCREST SUBDIVISION, as shown in Exhibit I (attached hereto), incorporated herein by reference, is hereby approved.




