ORDINANCE NO. 23

BE IT ORDAINED BY THE CITY COUNCIL of the City of LeRoy, McLean County,
Illinois this 3rd day of May, A.D. 1976, that

WHEREAS, Wendell S. Crumbaugh and Joreece Crumbaugh, being all of the owners of Lots 7, 8 & 9 in the Crumbaugh First Addition to the City of LeRoy as approved by former Ordinance on file herein, have petitioned this Council to alter said Plat and Sub-division eliminating the exception for the cul de sac from Lots 7 and 8, and have the boundary dividing Lots 7 and 8 changed according to the plat filed herewith, and to have the South boundary of Lots 7 and 8 coincide with the North line of Washington Street to its Eastern terminus, and dedicate to the City of LeRoy all except the east 8 ft of Lot 9 as an easterly extension of Washington Street.

IT APPEARING to the Council, that there are no other parties interested in said Plat, and that it is for the best interests of said City, that same be ordained,

IT IS HEREBY ORDAINED, that the cul de sac from Lots 7 and 8 be, and the same is hereby vacated, and that portion of said cul de sac from Lots 7 and 8, lying North of the North line of Washington Street shall become a part of Lots 7 and 8, and that the boundary line dividing Lots 7 and 8 of said Subdivision be changed in accordance with the plat filed herewith. All except the east 8 ft. of Lot 9 be dedicated to the City of LeRoy, in accordance with the plat filed herewith.

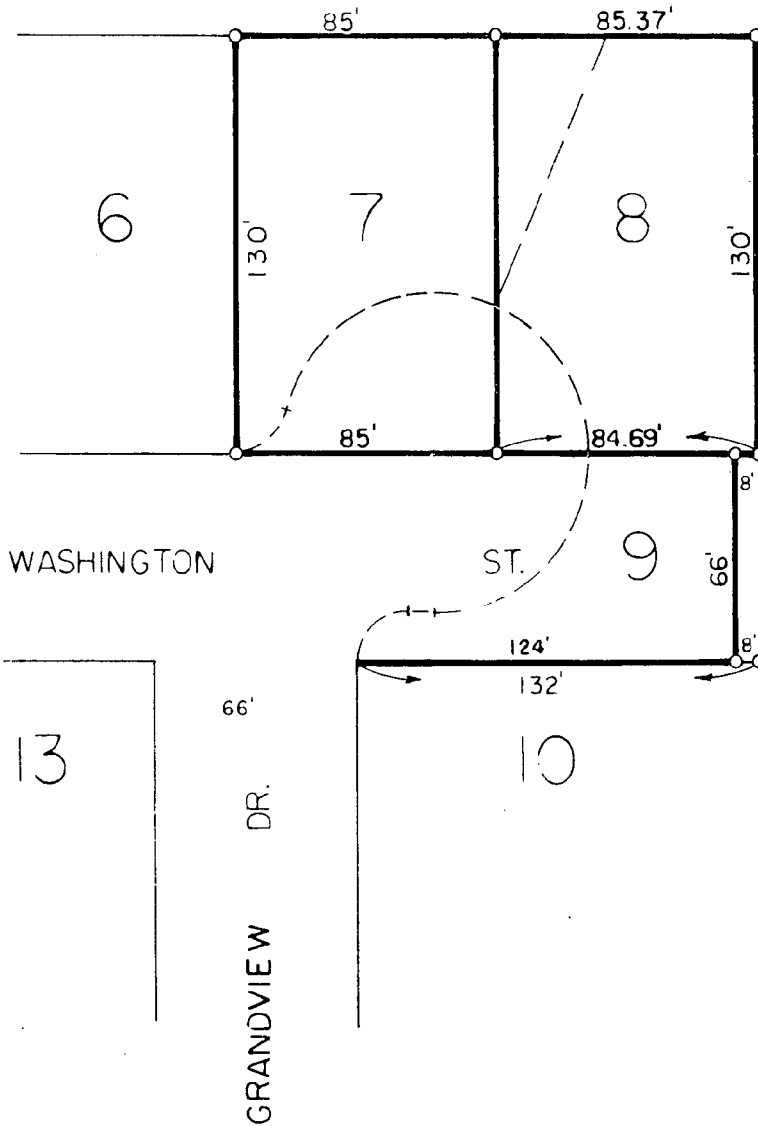

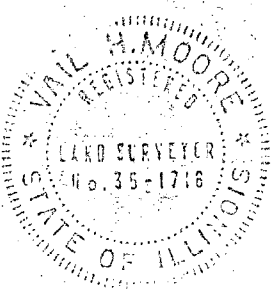
